

**RESOLUTION NO. 2023-09-424**

**A RESOLUTION OF THE CITY COMMISSION OF LYNN HAVEN, FLORIDA, CLARIFYING EXEMPTIONS TO THE STORMWATER SERVICE ASSESSMENT FOR STORMWATER RELATED SERVICES, FACILITIES AND PROGRAMS; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE.**

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LYNN HAVEN, FLORIDA, AS FOLLOWS:**

**SECTION 1. AUTHORITY.** This Resolution of the City of Lynn Haven, Florida (the "City") is adopted in a manner consistent with Ordinance No. 1102, as amended from time to time, Resolution No. 2021-07-360 and Resolution No. 2023-08-412, as amended from time to time, Sections 166.021 and 166.041, Florida Statutes, other applicable provisions of law to impose assessments and ultimately collect such assessments through the uniform collection method authorized by Section 197.3632, Florida Statutes.

**SECTION 2. AMENDMENT OF EXEMPT PROPERTIES.**

Section 3.07 (E) of Resolution 2021-07-360 is amended by deleting subsection (E) in its entirety and inserting in lieu thereof the following: "(E) parcels with less than 400 square feet of measured gross area".

Section 4. (H) (5) of Resolution 2021-08-364 is amended by deleting subparagraph (5) of subsection H in its entirety and inserting in lieu thereof the following: "(5) parcels with less than 400 square feet of measured gross area".

Section 4. (H) (5) of Resolution 2022-09-392 is amended by deleting subparagraph (5) of subsection H in its entirety and inserting in lieu thereof the following: "(5) parcels with less than 400 square feet of measured gross area".

Section 3.07 (E) of Resolution 2023-08-412 is amended by deleting subsection (E) in its entirety and inserting in lieu thereof the following: "(E) parcels with less than 400 square feet of measured gross area".

Section 4. (H) (5) of Resolution 2023-09-415 is amended by deleting subparagraph (5) of subsection H in its entirety and inserting in lieu thereof the following: "(5) parcels with less than 400 square feet of measured gross area".

**SECTION 3. REPEAL OF INCONSISTENT RESOLUTIONS.** Any resolutions or parts thereof in conflict herewith are hereby superseded and repealed to the extent of such conflict.

**SECTION 4. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its passage and adoption.
